### Clean Distribution GBP Shares

This is a sub fund of Tilney UCITS ICAV (the "ICAV"). The ICAV is a UCITS Irish collective asset-management vehicle. ISIN: IE00BK723541  
KBA Consulting Management Limited is the UCITS Management Company of the ICAV (the "Management Company").

## Objectives and Investment Policy

The investment objective of the Fund is to deliver income with the potential for capital growth over the longer term whilst aiming to minimise the variability of returns.

The Fund is a fund of funds so primarily holds investments in underlying funds which include funds, exchange traded funds (ETFs), investment trusts and investment companies. The underlying funds will invest in debt instruments (bonds), financial contracts that derive their value from bonds or indices (derivatives). The Fund will invest in a higher proportion of income-oriented strategies utilising income/distribution shares of underlying funds to maximise income received. The underlying funds may be established in a broad range of countries and will invest internationally. The Fund may also invest directly in bonds.

Derivatives may be used for efficient portfolio management, investment and hedging purposes.

The Fund is actively managed, which means that the investment manager takes decisions with the intention of achieving the Fund's investment objectives and this may include decisions on asset selection, regional allocations, sector views and overall market exposures.

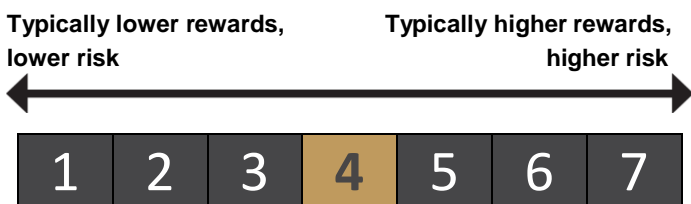
The Fund is not managed by reference to a benchmark.

All income and gains generated by the Fund will be reinvested.

## Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The highlighted area in the table below shows the Fund's ranking on the Risk and Reward Indicator



The Fund is in this category due to the nature of its investments and previous levels of volatility (how much the value of the Fund rises and falls).
