This is a sub fund of Tilney UCITS ICAV (the "ICAV"). The ICAV is a UCITS Irish collective asset-management vehicle. ISIN: IE00BMD8FN21
KBA Consulting Management Limited is the UCITS Management Company of the ICAV (the "Management Company").

Objectives and Investment Policy

The investment objective of the Fund is to seek to achieve capital growth over the long term, predominantly investing directly in equity markets.

The Fund will seek to invest primarily in a concentrated portfolio of equities from around the globe. The portfolio will normally consist of between 20 and 30 equity holdings representing at least 90% of the portfolio. The Fund may also have exposure to emerging markets. The remainder of the Fund will hold collective investment schemes (CIS), including exchange traded funds (ETFs), contractual funds, investment trusts and investment companies as well as sovereign, investment grade, non-investment grade and unrated bonds. The Fund may also invest indirectly in commodities.

Derivatives may be used for efficient portfolio management, investment and hedging purposes.

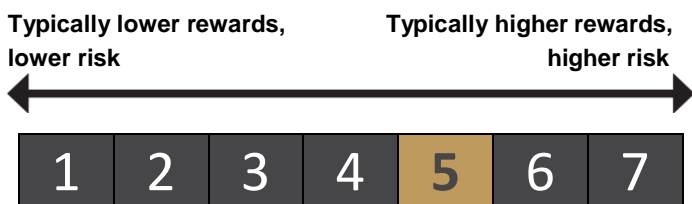
The Fund is actively managed, which means that the investment manager takes decisions with the intention of achieving the Fund's investment objectives and this may include decisions on asset selection, regional allocations, sector views and overall market exposures.

The Fund is not managed by reference to a benchmark.

All income and gains generated by the Fund will be reinvested. For full investment objectives and policy details please refer to the Prospectus and the Fund Supplement.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The highlighted area in the table below shows the Fund's ranking on the Risk and Reward Indicator



The Fund is in this category due to the nature of its investments and previous levels of volatility (how much the value of the Fund rises and falls).
