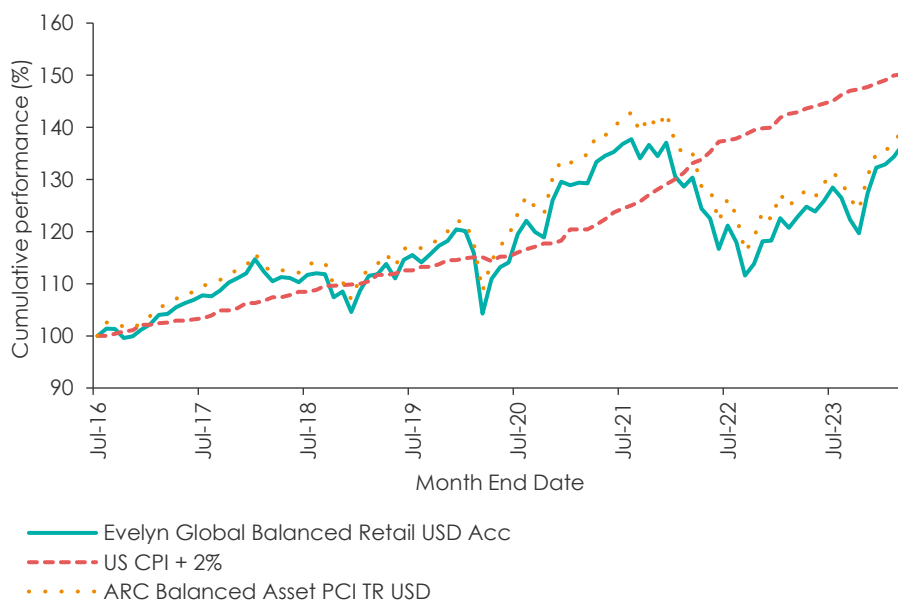
### Investment objectives of the fund

The Balanced Fund aims to deliver a real return, ahead of cash over the long term. The Fund is riskier than the Income Fund but has the potential to give you higher returns. The Fund can invest across all asset classes and adopts a moderate risk approach.

### Cumulative performance (%)

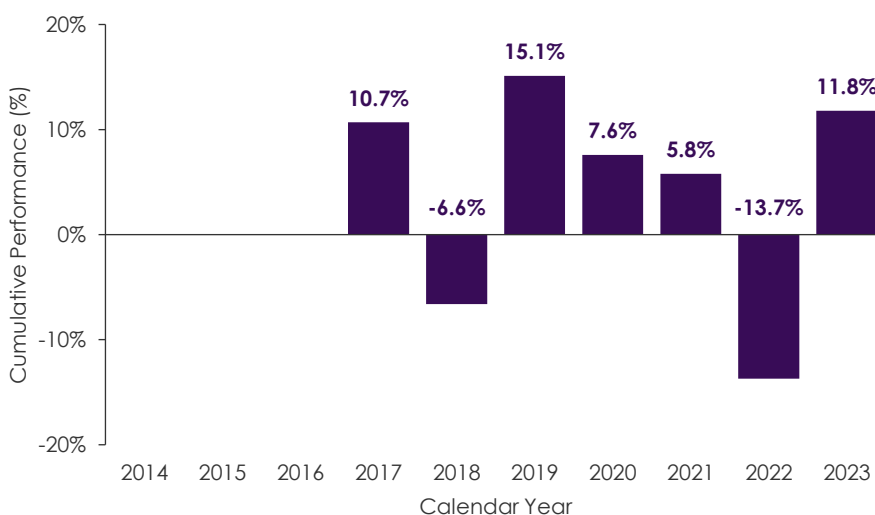

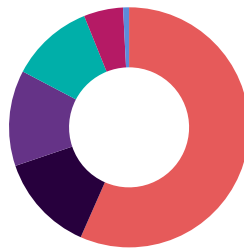

## Asset allocation & geographic equity allocation

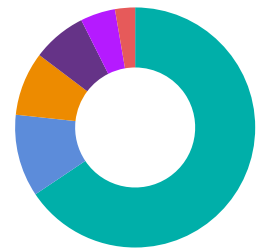
